Formal Course Description

Chemical Engineering 2E04 focuses on the formulation and solution of various engineering problems. We review a variety of techniques for numerical solution of linear and nonlinear model equations, including algebraic and ordinary differential equations, and the use of curve-fitting and interpolation methods.

Informal Course Description

A course dedicated to solving **hard problems** by approximating them as a ***bunch of easier problems*** solved efficiently and with high precision to minimize the errors introduced via simplification.

Learning Objectives

After completing this course, the student should be able to:

- L.1. Recognize when numerical methods should be applied as a part of a solution to a variety of chemical engineering (and other) problems or opportunities.
- L.2. Formulate mathematical models of common engineering unit operations and processes.
- L.3. Identify the appropriate algorithm or numerical method suitable for the solution.
- L.4. Break down how an algorithm works based on fundamental mathematical concepts.
- L.5. Implement algorithms using calculators and (more importantly) software tools.
- L.6. Derive algorithms for new problems based on a fundamental understanding of the objective.
- L.7. Use a numerical solution to help solve the original problem of interest.
- L.8. Identify the critical differences, advantages, and disadvantages of numerical versus analytical techniques.

Evidence of Objectives

Evidence to prove that one has achieved the above objectives may be demonstrated by:

- Explaining to a peer the fundamental concepts which are used in an algorithm.
- Using graphs and tables to illustrate how an algorithm works.
- Deriving potential algorithms to solve a problem from fundamental concepts.
- Coding an algorithm in a software tool such as python and proving that it works.
- Executing part of an algorithm "by hand" to show an understanding of core applied mathematics.
- Suggesting alternative algorithms for previously unsolved problems.
- Implementing the results of an algorithm in the final solution of the original problem.
- Explaining the importance of solving a problem (with or without numerical methods) in the first place.

Grading Policies

Please be aware of the following grading policies for ChE 2E04:

- Mastery problems have flexible due dates and therefore cannot be the subject of an MSAF.
- Valid MSAF submissions for midterms will result in either a make-up examination or rolling of that component's weight into the final exam, depending on the situation. The lab exam cannot be transferred.
- All assessments in this course are open-book (any book) and open-notes (any hard copies).
- Any calculator, but not computers, may be used for in-person written examinations.

- The instructor retains the right to modify course weights or components; this is typically only enforced for the student's benefit. All grades are **unofficial** until final grades are posted on MOSAIC.
- Final grades will be converted to the standard McMaster 12-point scale.
- All submissions for mastery problems must be done **electronically**.

Homework

Homework is a series of 10 short assignments worth 0.5% of your final grade each for a total of 5% to be completed individually and submitted to a dropbox on A2L. Homework must be **handwritten** unless an SAS accommodation is granted that exempts a student from this requirement. If you qualify for an exemption, please contact Stuart before the submitting your first homework assignment. Homework may be photographed or scanned to facilitate upload to the A2L online dropbox. Handwritten work done on a tablet or other digital annotation tool (e.g., MS OneNote) is acceptable. McMaster Student Absence Forms (MSAF) will not be accepted for Homework; instead, the dropbox for every homework assignment will remain open until 3 weekdays after the original deadline (Wednesday for a deadline of the preceding Friday) with all submissions prior to the dropbox closing being marked without a late penalty. Homework **will not be accepted** after the 3rd weekday following the deadline. This effectively means that everyone receives 10 free MSAFs for homework assignments. **Do not mistake** the dropbox closed date for the deadline, they are not the same.

Python Fundamentals Test

The python fundamentals test is a competency assessment that evaluates students' core programming skills needed to derive and implement algorithms (L5, L6). It is a short, in-person, proctored test on python implementation necessary for exploring and applying the numerical methods techniques taught in this course.

- The python fundamentals test must be completed individually in a proctored environment
 - The test is graded as **successful/unsuccessful**
 - The test will have 12 questions in total
 - The test will have a 90 minute time limit
 - Students must correctly answer 9 questions to pass the python fundamentals test and receive a **successful** grade

- There will be two chances to complete the competency assessment:
 - Wednesday, September 23 @ 6:30 pm
 - Wednesday, October 7 @ 6:30 pm
- If you receive an **unsuccessful** on both attempts, you must achieve a score $\geq 60\%$ on at least two of the three Lab Tests
- The python fundamentals test covers basic python syntax, use of the **numpy** library for vector, matrix, and scalar math, and use of the **matplotlib** library for data visualization

Midterm Tests

The midterm tests are short (90 minute) tests that cover all un-tested lecture modules up until the date of the test. The first midterm is expected to cover modules 1A – 2A. The second midterm is expected to cover modules 2B – 4A. These tests will be handwritten with three (3) double-sided crib sheets allowed for each test. Crib sheets must be handed in with each test and will be returned to you when the test is returned. Each test will have a re-write in the first lecture period following the test. Re-writes are done in groups of 4 and graded simultaneously with your individually written midterm. Your midterm grade will be the higher of 100% of your individual midterm or 85% of your individual midterm plus 15% of your group re-write midterm.

Written Exam

The written exam is a single, long (150 minute) summative test comprising 40% of the final course grade that covers all course material from lecture modules. The test is handwritten with five (5) double-sided crib sheets and McMaster approved calculators allowed as aids. No other aids are permitted. The date, time, and location of the exam is set by the registrar and will be released by the registrar partway through the term.

Lab Tests

The lab tests are a series of short (60 minute), in-person proctored tests on python implementation and application of numerical methods. You may bring in 3 double-sided crib sheets for each lab test. You will be provided the test questions on paper and required to submit handwritten answers and a coded solution to test questions. Your test paper and crib sheets will be collected and returned to you after grading. Your coded solution must be submitted to an online dropbox. Lab tests must be completed on UTS terminals – no personal computing devices are allowed. All cell phones and electronic devices (besides McMaster approved calculators) must be stored in your backpack or bag at the front of the room.

Tutorial Quizzes

Every tutorial session will offer a weekly mini-quiz (15 minutes; ~3 questions) on material covered during the tutorial. These quizzes will be focused on python implementation and algorithms discussed in lecture modules or tutorial worksheets. Each quiz is optional but may be worth up to 1% of your final grade: you may drop your lowest lab test result and replace it with the aggregate score of your best 10 tutorial quizzes. These quizzes will be held in the final 20 minutes of each tutorial session.

Mastery Problems

Mastery problems are real-world applications of numerical methods and computing applied to engineering problems. These problems have been curated to expose students to the power of numerical computing while also allowing for a low-risk method to earn credit for computing work. A brief description is as follows:

- Mastery problems must be completed individually or in pairs.
 - Each problem is graded as **successful/unsuccessful**.
 - The numerical answers (but not solutions) to each mastery problem are provided so you can be confident in your solution before submitting
 - You can only submit each mastery problem a single time
 - You can book **office hours** with the instructor and TAs to help you and receive feedback.
 - You choose your own pairs and may submit each problem with a different partner if you wish.
- There are five mastery problems each **worth 0.5% BONUS** to your course grade for a maximum of 2.5% bonus in total.
- Mastery problems must be submitted **electronically** via the appropriate A2L drop box.
 - **Only one** group member should submit the problem.
 - Pay attention to the submission guidelines on the front page of each problem.

Academic Honesty

You are expected to exhibit honesty and use ethical behaviour in all aspects of the learning process. Academic credentials you earn are rooted in principles of honesty and academic integrity.

Academic dishonesty is to knowingly act or fail to act in a way that results or could result in unearned academic credit or advantage. Some of the codes will use pre-built functions or even previous codes we have developed! Mastery problems may also refer to these codes.

All in-class codes will be posted on A2L for you to use freely.

Tutorials

Note that although tutorial worksheets are not graded, it is strongly recommended that students work through them at their own pace. Each tutorial contains important information relevant to the course and will appear in tutorial quizzes or other assessments. Tutorial time may also be used to work on **mastery problems**, but the instructional team's time will be prioritized to helping students with the tutorial activities.

Assumed Knowledge and Getting Help

`python` is one of the key tools which you will learn to use in this course. `python` is both a programming language and a math tool. All chemical engineering students are required to complete both a programming course in their first year and use `python` in their second-year math courses. This course will aim to equip students to use `python` in the future and be more successful in their math courses.

This course is built assuming that students are at least familiar with concepts covered in first year, such as:

- Basic program flow
- Variables and memory
- IF statements
- FOR loops
- Functions
- Basic data plotting

To help students, a variety of learning aids have been posted on the course website, including a **python primer** and **practice questions** for your python fundamentals test.

Office Hours: Teaching assistants will lead optional office hours where you can review tutorial or lecture material or ask questions about mastery problems. There are 5 office hours sections per week with TAs, plus a section with the instructor.
