Course Delivery Mode: All classes are in-person.

Course Description: This course provides fundamental in-depth knowledge of the physical principles and operational characteristics of semiconductor devices. The major emphasis is on band theory and an introduction to non-equilibrium charge carriers, junction diodes, bipolar junction transistors (BJT), and related devices such as photodiodes, LEDs, and solar cells. The physics and some applications of various versions of these devices will be considered. This course also lays a necessary foundation for MOSFET transistors and specialized devices treated in level four courses. The course includes four graded assignments, one term test, 4 laboratory experiments, and a final examination.

Prerequisite(s): Credit in at least one of the following: ELECENG 2E14, ENGPYHS 3BA3, 3BA4, 3SM3, MATLS 2Q03 or Registration in ENGPYHS 3SM3

Antirequisite(s): MAT3Q03

Class participation: Your class participation grade depends on your Powerpoint presentation on the solution to one homework problem. Students will prepare and provide these presentations in class as a group of three students. Since there are 45 students, we expect that there will be 15 homework problem presentations over the semester. These presentations will occur in the first 5-10 minutes of the lecture slots.

You will be assigned a date and a question for your presentation at least one week ahead of time. You must all three present as scheduled otherwise you will lose 6% of the final course grade immediately!

If you fail again to present on your second chance, you will lose another 6% of your final course grade and will receive a maximum of 8/20 for classroom participation.

The remaining 8% of your final grade is based on attendance. You must attend each class and miss no more than 5 lectures in total. Each missed lecture beyond 5 lectures is a drop of 2% and 9 missed lectures is therefore a loss of 8/20.

If you have special circumstances that will require you to miss more than 5 lectures, please discuss this with the course instructor ahead of time.

REQUESTS FOR RELIEF FOR MISSED ACADEMIC WORK

In the event of an absence for medical or other reasons, students should review and follow the Academic Regulation in the Undergraduate Calendar "[Requests for Relief for Missed Academic Term Work](#)". An abbreviated version is provided below.

The University recognizes that students periodically require relief from academic work due to extenuating circumstances. Students seeking relief for missed academic term work are expected to read the **McMaster Student Absence Form Policy**. The Policy aims to manage these requests by taking into account the needs and obligations of students, instructors and administrators. It is the prerogative of the instructor of the course to determine the appropriate relief for missed term work in their course. Any concerns regarding the granting of relief should be directed to the Faculty Office.

1. **Relief for missed academic work worth less than 25% of the final grade resulting from medical or personal situations lasting up to three (3) calendar days:**
 - Use the [McMaster Student Absence Form](#) (MSAF) on-line self-reporting tool. No further documentation is required.
 - Students may submit requests for relief using the MSAF once per term.
 - An automated email will be sent to the course instructor, who will determine the appropriate relief. Students must immediately follow up with their instructors. Failure to do so may negate the opportunity for relief.
 - The MSAF cannot be used to meet a religious obligation or to celebrate an important religious holiday.
 - The MSAF cannot be used for academic work that has already been completed or attempted.
 - An MSAF applies only to work that is due within the period for which the MSAF applies, i.e. the 3-day period that is specified in the MSAF; however, all work due in that period can be covered by one MSAF.
 - The MSAF cannot be used to apply for relief for any final examination or its equivalent. See *Petitions for Special Consideration* above.
2. **For medical or personal situations lasting more than three (3) calendar days, and/or for missed academic work worth 25% or more of the final grade, and/or for any request for relief in a term where the MSAF has been used previously in that term:**
 - Students must report to their Faculty Office to discuss their situation and will be required to provide appropriate **supporting documentation**.
 - If warranted, the Faculty Office will approve the absence, and the instructor will determine appropriate relief.
