Course Name: Advanced water and wastewater treatment processes Course Code: CIV ENG 735

Session Offered: Fall 2023

Calendar Description:

- 1. Membrane filtration systems: microfilters and ultrafilters in drinking water treatment; membrane bioreactors in wastewater treatment; nanofiltration and reverse osmosis in desalination and water reclamation; ion-exchange membrane applications.
- 2. Advanced oxidation processes: OH radical reactions; kinetics of radical chain reactions; OH radical production using ozone, hydrogen peroxide, ultra violet radiation, and photocatalysis.
- 3. Bioelectrochemical systems for wastewater treatment: thermodynamics and kinetics of electrode reactions; ionic transport under electric fields; exoelectrogenic bacteria; microbial fuel cells; microbial electrolysis cells; electroanalytical techniques using potentiostats.

AUTHENTICITY / PLAGIARISM DETECTION

Some courses may use a web-based service (Turnitin.com) to reveal authenticity and ownership of student submitted work.
