

ENGPHYS 3BA3 Electronics I: Circuits with Non-Linear and Active Components Fall 2023 Course Outline

CALENDAR/COURSE DESCRIPTION

This course provides the theory as well as the practical introduction to semiconductor electronics including P-N junctions, diodes, bipolar junction transistors, field effect transistors, DC and AC modeling, differential and operational amplifiers, feedback and oscillators, digital circuits and multivibrators, signal processing.

In this course, students will learn how to build a computer, starting from sand.

COURSE POLICY ON MISSED WORK, EXTENSIONS, AND LATE PENALTIES

- 1. Submission of an msaf gives an automatic extension of 5 days for reports and assignments. The extension counts from the original due date, NOT from the day of the msaf submission.
- 2. Submission of an msaf for a pre-lecture quiz gives an exemption for that quiz, i.e. its weight is reweighted to the other quizzes.
- 3. Late submissions of reports and assignments incur a penalty of 10% per day.

SUBMISSION OF REQUEST FOR RELIEF FOR MISSED ACADEMIC WORK

In the event of an absence for medical or other reasons, students should review and follow the Academic Regulation in the Undergraduate Calendar "Requests for Relief for Missed Academic Term Work".

- 1. Relief for missed academic work worth less than 25% of the final grade resulting from medical or personal situations lasting up to three calendar days:
 - Use the <u>McMaster Student Absence Form</u> (MSAF) on-line self-reporting tool. No further documentation is required.
 - Students may submit requests for relief using the MSAF once per term.
 - An automated email will be sent to the course instructor, who will determine the appropriate relief. Students
 must immediately follow up with their instructors. Failure to do so may negate the opportunity for relief.
 - The MSAF cannot be used to meet a religious obligation or to celebrate an important religious holiday.
 - The MSAF cannot be used for academic work that has already been completed attempted.
 - An MSAF applies only to work that is due within the period for which the MSAF applies, i.e. the 3-day period that is specified in the MSAF; however, all work due in that period can be covered by one MSAF.
 - The MSAF cannot be used to apply for relief for any final examination or its equivalent. See *Petitions for Special Consideration* above.
- 2. For medical or personal situations lasting more than three calendar days, and/or for missed academic work worth 25% or more of the final grade, and/or for any request for relief in a term where the MSAF has been used previously in that term:
 - Students must report to their Faculty Office to discuss their situation and will be required to provide appropriate supporting documentation.
 - If warranted, the Faculty Office will approve the absence, and the instructor will determine appropriate relief.
