Course Delivery Mode: All classes are in-person.

Course Description: This course covers the theory, design and operation of photonic devices such as waveguides, couplers, modulators, detectors and lasers, and their applications in integrated and fiber optical systems for communications, information processing and sensing.

Three lectures, one lab (three hours each) four times per term; one tutorial, winter term

COURSE INTENDED LEARNING OUTCOMES

By the end of this course, students should be able to:

- Demonstrate fundamental knowledge related to photonic devices
- Understand the theory of planar, ridge and fiber-optical waveguides
- Understand the basic operation of passive photonic devices including splitters/combiners and cavities
- Understand the basic operation of active photonic devices including switches, modulators and photodetectors
- Simulate various properties and the operation of photonic devices and systems using commercial software
- Experimentally characterize silicon passive and active integrated photonic devices using a fiber-optic probe station
- Demonstrate knowledge of applications of photonic integrated circuits and fiber-optic devices and systems

COURSE POLICY ON MISSED WORK, EXTENSIONS, AND LATE PENALTIES

1. It is the students' responsibility to regularly check the course webpage (Avenue to Learn) for updates and announcements.
2. Missed work and late polices:
 - A McMaster Student Absence Form (MSAF, <https://www.mcmaster.ca/msaf/>) must be submitted to the course instructor (Jon Bradley, jbradley@mcmaster.ca) not to the TA, for all missed work, otherwise a late penalty of -5%/day for late assignments and lab reports up to a maximum of -50% will be applied. The MSAF must normally be submitted within 2 WORKING DAYS of the missed work. If an MSAF is submitted, 1 extra week will be given from the regular assignment or lab report due date.
 - All assignments and lab reports must be completed. A grade of zero will be given for any incomplete assignment or lab report.

GENERATIVE AI

Students may use generative AI for editing/translating/outlining/brainstorming/revising their work throughout the course so long as the use of generative AI is referenced and cited following citation instructions given on Avenue to Learn. Use of generative AI outside the stated use of editing/translating/outlining/brainstorming/revising their work with citation will constitute academic dishonesty. It is the student's responsibility to be clear on the limitations for use and to be clear on the expectations for citation and reference and to do so appropriately. Students must prepare their assignments, lab reports, and team projects themselves, including working out solutions and carrying out simulations themselves, and be able to explain the work they submit.

REQUESTS FOR RELIEF FOR MISSED ACADEMIC WORK

In the event of an absence for medical or other reasons, students should review and follow the Academic Regulation in the Undergraduate Calendar [“Requests for Relief for Missed Academic Term Work”](#). An abbreviated version is provided below.

The University recognizes that students periodically require relief from academic work due to extenuating circumstances. Students seeking relief for missed academic term work are expected to read the **McMaster Student Absence Form Policy**. The Policy aims to manage these requests by taking into account the needs and obligations of students, instructors and administrators. It is the prerogative of the instructor of the course to determine the appropriate relief for missed term work in their course. Any concerns regarding the granting of relief should be directed to the Faculty Office.

1. **Relief for missed academic work worth less than 25% of the final grade resulting from medical or personal situations lasting up to three (3) calendar days:**

- Use the [McMaster Student Absence Form](#) (MSAF) on-line self-reporting tool. No further documentation is required.
 - Students may submit requests for relief using the MSAF once per term.
 - An automated email will be sent to the course instructor, who will determine the appropriate relief. Students must immediately follow up with their instructors. Failure to do so may negate the opportunity for relief.
 - The MSAF cannot be used to meet a religious obligation or to celebrate an important religious holiday.
 - The MSAF cannot be used for academic work that has already been completed or attempted.
 - An MSAF applies only to work that is due within the period for which the MSAF applies, i.e. the 3-day period that is specified in the MSAF; however, all work due in that period can be covered by one MSAF.
 - The MSAF cannot be used to apply for relief for any final examination or its equivalent. See *Petitions for Special Consideration* above.
2. **For medical or personal situations lasting more than three (3) calendar days, and/or for missed academic work worth 25% or more of the final grade, and/or for any request for relief in a term where the MSAF has been used previously in that term:**
- Students must report to their Faculty Office to discuss their situation and will be required to provide appropriate **supporting documentation**.
 - If warranted, the Faculty Office will approve the absence, and the instructor will determine appropriate relief.

ACADEMIC ACCOMMODATION FOR RELIGIOUS, INDIGENOUS OR SPIRITUAL OBSERVANCES (RISO)
