To provide an in-depth understanding of the engineering principles behind a selected number of biophotonics applications in life sciences (e.g. superresolution microscopy, fluorescence lifetime imaging, high content screening, etc.) and clinical applications (diffuse optical tomography, time-resolved fluorescence spectroscopy, optical coherent tomography, photoacoustic microscopy, etc.) as well as key tools used these research areas including ImageJ, image processing, pattern recognition and classification.
