# COURSE INTENDED LEARNING OUTCOMES

By the end of this course, students should be able to:

- 1. Develop the compressible flow equations for 1-d flow with area changes, heat addition and friction
- 2. Analyse 1-d compressible flows with area changes, heat addition and friction
- 3. Analyse 2-d compressible flows with oblique shocks and expansion fans
- 4. Perform calculations on and describe the general properties and efficiencies of the flow through axial compressors and turbine cascades
- 5. Demonstrate an understanding of the air flow through wind turbines, and the limits on their power generation
- 6. Analyse power generation from wind turbines from the viewpoint of both developers and control engineers.
