| 2. COURSE SPECIFICS    |   |   |  |                           |  |  |
| Course Description     | The ability to integrate various industries that affect manufacturing using computer systems has resulted into a new manufacturing paradigm generally referred to in literature as Industry 4.0, Digital Industry or Industrial Internet of Things (IIoT). This paradigm seeks to leverage the potential optimization in production and logistics caused by increased and integrated industrial automation, intelligent system monitoring, and autonomous decision-making that is supported by real-time or almost real-time communication at all levels. This course covers the network technologies that support system integration of process/manufacturing automation, building automation, environment management, as well as energy management and electricity systems automation (smart grid systems). In other words, the course covers the network infrastructure of IIoT. Moreover, the course covers other IIoT infrastructure components such as energy monitoring, manufacturing control, and building automation systems, as well as Artificial Intelligence based control systems. #### 5. LEARNING OUTCOMES

- 1. Understand the concepts of systems integration as applied to Industrial Internet of Things (IIoT)
- 2. Identify hardware and software requirements for automation system integration and be able to offer solutions.
