## **5. LEARNING OUTCOMES**

1. To provide a good understanding of the manufacturing processes for different materials
2. To teach the basic tools for numerical control programming and simulation
3. To provide hands-on experience with operating CNC machines, injection molding and thermoforming machines, and rapid prototyping printers used in manufacturing processes
