CALENDAR DESCRIPTION

A course on the analysis, simulation and design of power converter systems. Main topics include: high-power multi-pulse rectifiers, multilevel voltage and current source converters, pulse width modulation, harmonic reduction techniques, modeling and simulation techniques, and industrial applications. Important concepts are illustrated with design projects using Matlab/Simulink.

COURSE OBJECTIVES

At the end of this course, the successful student will have a solid knowledge on the converter topologies, operating principles, modulation techniques and control of a variety of high-power converters with a voltage rating of a few kilovolts and power rating in the megawatt range. The students will be able to analyze and design these converters using commercial simulation tools such as Matlab/Simulink.

ASSUMED KNOWLEDGE

It is assumed that the students have the basic knowledge of Power Electronics.
