CALENDAR/COURSE DESCRIPTION

Kinematics and dynamics of rigid bodies. Analysis of planar mechanisms. Displacement, velocity and acceleration analysis methods. Motion with respect to a rotating frame reference. Work, energy and momentum principles.

COURSE INTENDED LEARNING OUTCOMES

By the end of this course, students should be able to:

- Analyse and solve one degree of freedom mechanical vibration problems,
- Draw free-body diagrams and kinetic diagrams,
- Apply physics, calculus, algebra, and trigonometry to solve kinematics and kinetics problems,
- Solve planar kinematics problems,



- Solve planar kinetics problems involving translation and rotation of multiple rigid bodies.
- Solve kinetics problems using approaches based on Newton's second law of motion; work and energy; and impulse and momentum.
- Analyze power and efficiency.

SUBMISSION OF REQUEST FOR RELIEF FOR MISSED ACADEMIC WORK

In the event of an absence for medical or other reasons, students should review and follow the Academic Regulation in the Undergraduate Calendar "Requests for Relief for Missed Academic Term Work".

1. Relief for missed academic work worth less than 25% of the final grade resulting from medical or personal situations lasting up to three calendar days:



- Use the <u>McMaster Student Absence Form</u> (MSAF) on-line self-reporting tool. No further documentation is required.
- Students may submit requests for relief using the MSAF once per term.
- An automated email will be sent to the course instructor, who will determine the appropriate relief. Students must immediately follow up with their instructors. Failure to do so may negate the opportunity for relief.
- The MSAF cannot be used to meet a religious obligation or to celebrate an important religious holiday.
- The MSAF cannot be used for academic work that has already been completed attempted.
- An MSAF applies only to work that is due within the period for which the MSAF applies, i.e. the 3-day period that is specified in the MSAF; however, all work due in that period can be covered by one MSAF.
- The MSAF cannot be used to apply for relief for any final examination or its equivalent. See Petitions for Special Consideration above.
- 2. For medical or personal situations lasting more than three calendar days, and/or for missed academic work worth 25% or more of the final grade, and/or for any request for relief in a term where the MSAF has been used previously in that term:
 - Students must report to their Faculty Office to discuss their situation and will be required to provide appropriate supporting documentation.
 - If warranted, the Faculty Office will approve the absence, and the instructor will determine appropriate relief.
