5. LEARNING OUTCOMES

- Analyse the stress and strain on machine components under various loading conditions.
- Study the effects of friction, stress concentration features and geometrical shape on the stresses.
- Design of machine elements with impact load, fatigue and factor of safety in mind.
- Identify the operating limits of the machine elements under various loading conditions.
- Disassemble and assemble automotive transmission and engines, identify their components, understand the design principles employed.
- Perform measurements for cylinders, pistons, journal bearings and connecting rods and understand the importance of the allowed tolerances and clearances required for proper operation.

AUTHENTICITY / PLAGIARISM DETECTION
