5. LEARNING OUTCOMES

1. Define pharmacology and compare the disciplines that pharmacology encompasses and draws from.
2. Compare the concepts of pharmacokinetics and pharmacodynamics and identify what measurable variables belong to each of those two disciplines.
3. Describe the relationship between dosage, side-effects, therapeutic effects, and toxicity.
4. Explain the main mechanisms of how drugs interact with their targets.
5. Describe the anatomical and physiological differences in each of the systems that are to be covered in the course.
6. Create reasons for the choice of drug delivery route(s) for the various disease states covered.
7. Identify the main underlying cause(s) of the disorders that will be covered during the term.
8. Propose pharmacological interventions for suggested pathologies and predict possible outcomes, both intended and unintended.
