5. LEARNING OUTCOMES
1. Develop time-space diagrams, cumulative plots and mathematical models relating time, distance, speed, density and flow.
2. Produce trip generation estimates, trip distribution matrices and modal split estimates.
3. Produce estimates of traffic impact from land development projects.
4. Determine modal split using attribute information of each transportation mode.

5. Produce manual trip assignments for small study areas.

6. Explain the role of transportation planning and engineering within the context of Civil Engineering Infrastructure Technology, including subdisciplines, career opportunities and software applications.

AUTHENTICITY / PLAGIARISM DETECTION

Some courses may use a web-based service (Turnitin.com) to reveal authenticity and ownership of student submitted work. No penalty will be assigned to a student who does not submit work to the plagiarism detection software.
