<b>Course Specific Policies</b>	Students are expected to attend all lecture sessions, and to complete and submit reports on all requested exercises. Week 1	Introduction to design process, codes, standards & specifications, loads on buildings
Week 2	Loads on buildings, design principles & limit states design
Week 3	Mechanical and physical properties of steel, advantages and concerns, residual stresses, structural steel products
Week 4	TENSION MEMBERS: factors influencing the behavior and strength, design clauses, net area, shear lag, other effects
Week 5	COMPRESSION MEMBERS: factors influencing the behavior and strength, short, intermediate and long columns
Week 6	COMPRESSION MEMBERS: effects of residual stresses and initial imperfections, effective length of single columns, and columns in continuous frames
Mid-term Recess: Monday, February 19 to Sunday, February 25	
Week 7	BEAMS: types of failure, laterally-supported beams, local buckling of elements, laterally-unsupported beams
Week 8	<b>Midterm Test (Tentative date).</b> <b>The date will be announced on Avenue-to-Learn ahead of time.</b>
Week 9	BEAMS: shear resistance, bearing resistance, web crippling, deflection of beams
