5. LEARNING OUTCOMES

1. Evaluate integrals involving algebraic, trigonometric, exponential, and logarithmic functions.
2. Evaluate integrals using various techniques such as substitution, trigonometric substitutions, integration by parts, and partial fractions.
3. Apply the concepts of definite integrals to solve problems involving area, volume, area of surface of revolution, and physical applications.
4. Use principles of integration to calculate velocity, net change, and work.
5. Evaluate the definite integral of a function f where the interval is infinite, and where f has an infinite discontinuity in a finite interval $[a, b]$.
6. Use double integrals to compute the volumes, masses, and centroids of more general regions.
7. Evaluate triple integrals, and solve application problems using the integral theorems of Green, Stokes, and Gauss.
