<b>Course Description</b>	The course introduces statistical methods for estimation, inference (hypothesis testing) and regression analysis. The course integrates the concepts and theorems of probability, probability distributions and their mathematical functions, random variables (both continuous and discrete), random sampling and the distinctive nature of samples drawn from populations. The emphasis is on practical decision making.

6. Use software applications to interpret, draw conclusions, and solving statistical problems from standard output generated by statistical software
