| Course Description | <p>The course deals with the fundamentals, theoretical bases, and design methodologies of electric vehicles (EVs), hybrid electric vehicles (HEVs), and fuel cell vehicles. It comprehensively covers vehicle performance characteristics, configurations, control strategies and design methodologies. It includes drive train architecture analysis, EV and HEV configurations, electric propulsion systems, series/parallel/mild hybrid electric drive train design methodologies, energy storage systems, regenerative braking, fuel cells and their applications in vehicles, and fuel cell hybrid electric drive train design.</p> | | |
