Requests for Relief for Missed Academic Term Work (Assignments, Mid-Terms, etc.)

- 1) Relief for missed academic work worth less than 25% of the final grade resulting from medical or personal situations lasting up to three calendar days:
 - Students may submit a maximum of one academic work missed request per term.
