COURSE OBJECTIVES

By the end of this course, students should be able to:

- Gain general knowledge of the fundamental physics governing the principal of the design and operation of optical instrumentation and general optical measurement techniques;
- Model basic optical instruments using industry standard ray-tracing software tools e.g., Zemax;
- Properly carry out measurements employing these instruments and analyze the data;
- Carry out self-directed learning of new instruments and devices;
- Follow general design principles to develop optical systems for real-world problems.
