COURSE INTENDED LEARNING OUTCOMES

By the end of this course, students should be able to:

- Explain the statistical underpinnings of thermodynamics
- Apply combinatorics to determine the microstates and macrostates of a system
- Explain the origin of equipartition theorem and use it to predict properties of a system
- Apply Boltzmann and quantum statistics to a wide range of topics (e.g., heat capacity, electrons in semiconductors, magnetism, blackbody radiation, adsorption, kinetic theory of gases)

COURSE FORMAT AND EXPECTATIONS

The course is organized as follows:

Students can earn a class participation mark of up to 10% of the final grade by attending and participating in the live lectures and tutorials (i.e., taking part in polls, breakout room discussions, etc.). A student’s participation mark will be 10% times the fraction of live components (lectures and tutorials) participated in. Other course assessments (assignments, tests, exam) will be reweighted to make up the remaining portion of the final grade. For example, if a student attends 70% of the live components they will receive 7% towards the final grade, with the other assessments reweighted to make up the remaining 93%. This is intended to encourage lecture and tutorial attendance without penalizing those who cannot or choose not to attend.

You are encouraged to discuss assignments with your classmates. However, posting, sharing and searching questions/answers on chegg.com and similar sites for is strictly forbidden. The calculations and the assignment that

you hand in must be your own work. In carrying out calculations on tests or assignments, it is important to explain what you are doing. In addition to helping with learning, explaining a rational thought process will score points even if the calculation is incorrect.

COURSE POLICY ON MISSED WORK, EXTENSIONS, AND LATE PENALTIES

SUBMISSION OF REQUEST FOR RELIEF FOR MISSED ACADEMIC WORK

1. **Relief for missed academic work worth less than 25% of the final grade resulting from medical or personal situations lasting up to three calendar days:**
 - Use the [McMaster Student Absence Form](#) (MSAF) on-line self-reporting tool. No further documentation is required.
 - Students may submit requests for relief using the MSAF once per term.
 - An automated email will be sent to the course instructor, who will determine the appropriate relief. Students must immediately follow up with their instructors. Failure to do so may negate the opportunity for relief.

 - The MSAF cannot be used for academic work that has already been completed attempted.

 - The MSAF cannot be used to apply for relief for any final examination or its equivalent. See *Petitions for Special Consideration* above.
2. **For medical or personal situations lasting more than three calendar days, and/or for missed academic work worth 25% or more of the final grade, and/or for any request for relief in a term where the MSAF has been used previously in that term:**
 - Students must report to their Faculty Office to discuss their situation and will be required to provide appropriate **supporting documentation**.
 - If warranted, the Faculty Office will approve the absence, and the instructor will determine appropriate relief.
