Learning outcomes

By the end of this course, students will understand that a phase diagram (any phase diagram!) is a graphical illustration of an outcome of a competition among the thermodynamic stabilities of phases. They will be able to use this paradigm for solving various real-life problems.

Also, the students will be capable of

1. Using the concept of the driving forces to construct phase diagrams
2. Interpreting and constructing $\ln p_i - \ln p_j$ predominance diagrams
3. Interpreting and constructing $\ln p_i - T$ predominance diagrams
4. Employing alternative reference states for handling iron and steel making processes
5. Realizing advantages and deficiencies of the interaction parameter formalism
6. Understanding isothermal and isoplethal sections of multicomponent phase diagrams and appreciating their practical importance
7. Interpreting and constructing Pourbaix diagrams

Textbook

Either “Introduction to the thermodynamics of materials” by David R. Gaskell (5th edition) or “Introduction to the thermodynamics of materials” by David R. Gaskell and David E. Laughlin (6th edition) is a mandatory textbook for this course.

By the end of course, the students will be intellectually comfortable with or at least not scared by the following chapters in this textbook:

1. Reaction involving gases
2. Reactions involving pure condensed phases and a gaseous phase
3. Reaction equilibria in systems containing components in condensed solutions
4. Electrochemistry

Course structure

1. Every week, there are two lectures and two tutorials delivered *via* Microsoft Teams. The participation is not controlled.
2. Due to COVID-19 realities, there are no labs.

AUTHENTICITY/PLAGIARISM DETECTION
