### 2. COURSE SPECIFICS

<b>Course Description</b>	<p>The focus of the course is on linear approaches to regression and classification, including selection and shrinkage methods for regression and linear discriminant approaches for classification. Additionally, modern approaches to implementing Big Data systems are examined. The online offering will include:</p> <ul style="list-style-type: none"> <li>• the availability of all lecture materials on McMaster's LMS</li> <li>• external resource links</li> <li>• weekly three-hour synchronous lectures (using Zoom)</li> <li>• weekly assignments using computer-based tools</li> </ul> <p>All approaches are implemented each week by the students in Python at a fundamental level and the behavior of the approaches is examined on small data sets (learning outcomes). Large scale problems are examined weekly through the use of Python library implementations of each approach. Students will complete a course project using Python which uses one algorithm to implement regression and one algorithm to implement classification.</p> <p>Graduate students will be expected to complete the weekly assignments with a focus on the extensions to the basic methods and are expected to complete a course project including the extensions.</p>
